**ACCEPTANCE:** The sale of the products or services offered by Stormwater Systems, Inc. is expressly conditioned upon the Buyers assent to the Terms and Conditions as set forth herein. If the Terms and Conditions stated in the Buyers Purchase Order are inconsistent with the Terms and Conditions contained herein, Stormwater Systems, Inc. acknowledgement of said order shall constitute a counter-offer, and the Buyer shall be deemed to have accepted Stormwater Systems, Inc. Terms and Conditions unless the Buyer notifies Stormwater Systems, Inc. to the contrary in writing within five (5) days after receiving the acknowledgement.

**LIMITED WARRANTY:** Stormwater Systems, Inc. warrants its products and services, to the original Buyer only, against defects in material and workmanship for a period of one (1) year from the date of delivery. This warranty is only in effect when exposed to the normal operational conditions as expressed by the Buyer and/or his Agent and as stated in the contract documents, quotation, or certified drawings. This limited warranty will not apply where damages are caused by misuse, abuse, neglect, accident, faulty installation or improper application of the product. Any modifications or alterations made to the goods without the authorization of Stormwater Systems, Inc. will void this limited warranty. Any equipment, component, machinery, or accessory furnished by the Seller as part of the goods, but manufactured by others is warranted only to the extent of the original manufacturer's warranty to the Seller. The Seller will not be responsible for consequential damages as a result of any such defective material or workmanship including but not limited to, the Buyers loss of material and profits, increased cost of operation, down time, reconstruction, or environmental consequences and in no event shall the Seller's obligation under this warranty exceed the original contract price of the defective item. Seller will be liable under this limited warranty only if the Buyer, at the time of delivery, provides Seller with written notice that a defect exists if a reasonable inspection of the equipment would have put the Buyer on notice as to the defect. Silent acceptance of the goods by the Buyer will constitute a waiver by the Buyer of the limited warranty. The warranty shall only be effective if the Seller has had a reasonable opportunity to investigate the alleged defect. If Seller determines upon examination at one of its factories or in the field, that the product or any part of it alleged to be defective is not defective or was not defective at the time of sale or delivery, the Buyer shall be entitled to no remedy under this warranty. Buyer may ship goods to Seller's factory only if written shipping instructions have been received from Seller.

**DELIVERY:** Stormwater Systems, Inc. will not be held liable for damages due to delay in or inability to complete, the manufacture and delivery of the product or performance of service due to labor difficulties from whatever cause arising, weather, acts of God, shipping delays, inability obtain equipment or materials from its sources of supply or qualified labor sufficient to fill its orders, or any other cause beyond the reasonable control of Stormwater Systems, Inc.

**PAYMENTS:** Payment for products or services is due Net 30 days from date of delivery. Note: A service charge of 1.5% per month will be charged on past due accounts.

**FABRICATED PRODUCTS:** When the products ordered are custom fabricated items and specially designed and manufactured to meet the Buyers specifications, the Buyer agrees to pay reasonable cost for any additional design, engineering and/or drawings required as a result of the Buyers actions, including but not limited to errors, omissions or specification changes. The Buyer will be responsible for the correctness of these drawings in depicting the desired product; his approval will be final and will be the authorization required to commit the product to fabrication. In the event of cancellation of order, the Buyer agrees to pay Stormwater Systems, Inc. a cancellation charge based upon the materials ordered and/or percentage of completion at the time of cancellation. The Buyer agrees to issue a Change Order, prior to start of fabrication, to cover any changes and/or cost differentials between the original quoted product and changes required.

**QUOTATIONS:** Unless otherwise stated all quotation prices are good for 30 days. If the buyer delays the manufacturing of the product or performance of the service beyond the projected delivery schedule through his actions including, but no limited to, request for extended delivery, failure to provide requested data, failure to approve drawings within a reasonable time, or requesting multiple engineering changes or revisions, a price increase may be imposed to reflect increases in material cost and labor rates which may occur between the time of original project delivery and actual delivery.

**ON-SITE SERVICE:** Any Stop/Start work time beyond the control of Stormwater Systems, Inc. including but not limited to, false mobilization, de-mobilization, plant process problems, construction delays, unacceptable welding conditions, (i.e. water, chemicals, not accessible, etc.) caused by others will be billed to the Buyer at Stormwater Systems, Inc. hourly rate, including expenses, (i.e. meals, lodging, travel, etc.)

**SCHEDULING DELIVERY:** Delivery schedule stated in the offer is an anticipated estimate based upon the projected work load at the time of the offer, the anticipation of the order placement, and the expedient processing of drawings by the Buyer. Therefore, unless otherwise stated, it is not to be the basis for scheduling other related work by the Buyer. A specific delivery date requirement must be stated in the Buyers Purchase Order and agreed to by Stormwater Systems, Inc. If Buyer is notified of pending delivery and is unable to accept delivery, the Buyer agrees to accept invoicing and any reasonable handling cost that may be incurred by Stormwater Systems, Inc. as a result of the requested delay.
