TENNIS COURT PAVING

Fine grade site using laser guided motor grader. Test roll and install 4" (compacted) crushed stone base using laser guided equipment and compact. Test roll and install 2" of 9.5mm "H" asphalt topping to tennis courts and compact. Tennis court shall be 200' x 120'.

(Demo of existing courts, fencing, and sub-base prep and proper compaction to within +/- 1/10 to be provided by the City of Griffin)

TENNIS COURT COLOR SYSTEM

Provide materials and labor necessary to apply a 4 coat Sealmaster tennis court color coat system to tennis courts per manufacturer's recommendations. Courts to be checked for birdbaths and all repairs necessary made before color coating commences. After courts have cured for a period of not less than 15 days, 2 coats of acrylic resurfacer (filler coats) will be applied and 2 coats of color coats applied. Layout and stripe the tennis courts. All tennis courts to be 36' x 72' per ASBA and USTCA rules and regulations.

NETS/POSTS/FOOTINGS

Net post sleeves to be set in 24'' x 24'' x 36'' concrete footings. Net posts and nets to be per specifications.

Quote includes 1 move-in for base crew and 1 move-in for asphalt crew. Additional move-ins are \$2,500.00 per crew. Any grading in excess of .2ft.+/- or correction required under other sections of the job specifications (unless otherwise specified) will be done at extra cost for any equipment and labor (including applicable insurance and payroll taxes) required. We are not responsible for acts of God, strikes, underground objects such as utilities, water or debris and other conditions beyond our control. Design grade shall be a minimum of 1% to insure drainage and a maximum of 12% to prevent slippage. Engineering, staking and testing are excluded from this proposal unless otherwise specified.

All work will be guaranteed against failure for a period of one year from completion, excluding loads in excess of the specified load limit, cracks, which will reappear eventually due to fluctuations in climate, or failure resulting from work performed by others.

If this contract is delayed or canceled for any reason not directly relating to the workmanship of Match Point Tennis or a failure of Match Point Tennis provided in writing with at least 30 days notice; the job will be considered a breach of this agreement and subject to a 5% penalty of the total amount in contract. This amount will be due no longer than 30 days from the date of cancellation.

All of the above work will be completed in a substantial and workmanlike manner according to standard practices for the sum of:

SIXTY SEVEN THOUSAND FOUR HUNDRED SEVENTY SIX DOLLARS ~ \$67,476

MADE IN PROGRESS PAYMENTS TO BE PROVIDED UPON STONE BASE INSTALLATION AND ASPHALT INSTALLATION WITH TERMS NO LONGER THAN NET 30 DAYS.

Our employees are fully covered by Worker's Compensation and General Liability Insurance. If payment due under this contract is not paid according to the terms and conditions specified above, and we retain an attorney who is not employed by Match Point Tennis, you agree to pay all attorney's fees and court costs and out of pocket expenses + 15% of the total non-collected past due amount.

Any alteration or deviation from the above specifications involving extra cost of material and or labor will be executed only upon written orders for same, and will become an extra charge over the sum mentioned in this contract. Paving and base stone quantities may vary from the original plans and therefore all quantities will be field measured at the time of completion and billed or credited accordingly. All agreements must be in writing. This proposal is good for fifteen (15) days from date of receipt.
