This is in reference to our conversation regarding acquisition services on the City of Griffin/ Spalding County project referenced above.

This is to advise you that my company will provide pre/post acquisition services at the rate of \$65.00 per hour for meeting with appraisers for real estate appraisals and specialty reports that may be needed. I will provide negotiation services at a flat rate fee of \$1,200.00 per parcel per interest, which includes any mileage expenses. Any parcel that can be donated, I will reduce the negotiation flat rate fee down to \$800.00 per parcel. Relocation negotiations, if necessary with owners or tenants, will be at a rate of \$800.00 per parcel per interest. Any parcel with a driveway easement only will be \$500.00 per parcel. It will be the responsibility of the City Attorney to close each parcel and obtain any releases needed to clear title prior to closing. Assistance to the City Attorney in closings and obtaining releases, if necessary, will be at a rate of \$65.00 per hour.

The scope of services for pre/post negotiation activities will include all coordination with City representatives regarding plan changes, project status information, relocation interviews with owners or tenants, project relocation and sign reports, cost estimates, project certification, preliminary and final field plan review meetings, parcel file review, coordination with the City Attorney to provide title reports, meetings with property appraiser and reviewing appraiser, conduct property owners meeting if required by the City.
