- 2. This bid is revised because COG Gibb Cotton requested a proposal for fiber installation at the Spalding County Sheriff Department. Job 32B OR Job 32B-1
- 3. Job will be constructed per map indicating fiber route and Walk Out with Gibb Cotton.
- 4. There may be additional charges if changes are made to map and/or Walk Out.
- 5. Prices include all labor, materials and restoration except for a Wall Mount Box for Job 32B or Job 32B-1. This is a used City of Griffin Wall Mount Box in excellent condition which was removed during completion of Job 33 - #4 Emlett Rd and Hill St.
- 6. Four Seasons Cable is not responsible for any damage to private owned utilities that are not located, however; we will assist the utility owner if damages occur.
- 7. Prices above does not include rock bores. If rock is discovered, the City of Griffin will be notified immediately of additional charges.
- 8. City of Griffin will apply for all necessary permits to complete jobs above.
- 9. Prices above are if jobs are completed at same time.
