Scope of Work: Sealant Replacement @ 6 Story Tower

Engineered Restorations, Inc. (ERI) proposes to furnish all the necessary labor, material, tools, equipment, supervision, and insurance to perform above work per the following specifications:

- Mobilize to access exterior building façade by means of swing stages.
- Provide Overhead Protection @ sidewalks, access, and egress points to protect pedestrians.
- At all precast joints, window perimeters, building to sidewalk perimeters, and roof flashing- remove existing sealants and mechanically clean joints to bare substrate.
- Install a backer rod and new Dow Corning silicone sealant per manufacturer's specifications and installation sheets.
- Tool all new joinery to a neat and professional appearance.
- The existing window sealants (glass to metal) will be trimmed back flush with the window mullion on the exterior of the building façade.
- Once removed the glass to metal and metal to metal joints within the window assemblies will be solvent wiped clean to remove any debris or contaminants.
- All prepped areas will be wet glazed using a Dow Corning silicone sealant based on manufacturer's specifications data sheets. All sealants will be tooled to a neat and professional appearance.
- New sealant colors to be chosen by others.
