COLLECTION SERVICE AGREEMENT NONHAZARDOUS WASTE

TERMS & CONDITIONS

- SERVICES RENDERED. Customer grants to the City of Griffin the exclusive right to collect and
 dispose of Customer's Waste Materials and including all Recyclables. Customer agrees to make the
 payments as provided for herein, and City of Griffin agrees to furnish such services as specified above, in
 all accordance with the terms of this Agreement.
- 2. TERM. The initial term (the "Initial Term") of this Agreement is two (2) years from the date hereof ("Service Effective Date"). This Agreement shall automatically renew for five (5) additional Terms of two years (a "Renewal Term") thereafter unless either party shall give written notice of termination by certified mail to the other at least sixty (60) days prior to the termination of the Initial Term or any Renewal term.
- 3. WASTE MATERIALS. The Waste Materials to be collected and disposed of by City of Griffin pursuant to this Agreement is all solid waste generated by Customer (the "Waste Material"). Waste Material specifically excludes and Customer agrees not to deposit or permit the deposit in the City of Griffin's equipment of place for collection by the City of Griffin any radioactive, volatile, corrosive, highly flammable, explosive, biomedical, infectious, bio-hazardous, toxic or hazardous waste, substance or material, as defined by applicable federal, state, provincial or local laws of regulations ("Excluded Waste"). Title to and liability for any Excluded Waste shall remain with Customer.
- 4. PAYMENTS. Customer agrees to pay the City of Griffin for the services and/or equipment furnished by the City of Griffin in accordance with the charges and rates provided for herein. Payment shall be made by customer to the City of Griffin within ten (10) days of the receipt of an invoice from the City of Griffin. Amounts outstanding for more than thirty (30) days shall accrue a service charge of five (5%) percent.
- 5. RATE ADJUSTMENTS. Because disposal and fuel costs constitute a significant portion of the cost of the City of Griffin's services, Customer agrees that the City of Griffin may increase its rates to adjust for any increase in such costs or any increase in the rates from time to time to adjust for increases in (a) U.S. Municipal Price Index (Urban Areas), (b) the City of Griffin's costs caused by changes in federal, state or local laws or regulations applicable to the City of Griffin's operations or (c) taxes, fees or other governmental charges assessed against or passed through the City of Griffin. Customer further agrees that the City of Griffin also adjusts its rates to account for any increases in the average weight per container yard of the Customer's Waste Material.
- 6. EQUIPMENT. The equipment furnished hereunder by the City of Griffin shall remain the property of the City of Griffin; however, Customer acknowledges that it has care, custody, and control of the equipment while at the Customer's location and accepts responsibility for all loss or damage to the equipment (except for normal wear and tear of or for loss or damage resulting from the City of Griffin's handling of the equipment) and for its contents. Customer agrees not to overload (by weight or volume) move or alter the equipment and shall use the equipment only for its intended purpose. Customer agrees to provide unobstructed access to the equipment on the scheduled collection day. If the equipment is inaccessible so that the regularly scheduled pick-up cannot be made, the City of Griffin will promptly notify the Customer and afford the Customer a reasonable opportunity to provide the required access/however, the City of Griffin reserves the right to charge an additional fee for any additional collection service required by Customer's failure to provide such access.
- 7. DAMAGE TO PAVEMENT. Customer agrees that the City of Griffin will not be responsible for any damage to Customer's pavement, curbing or other driving surfaces resulting from the weight of the City of Griffin's vehicles providing service at the Customer's location.
- 8. SUSPENSION AND TERMINATION FOR CAUSE. If, during the term of this Agreement, either party shall be in breach of or default in any provision of this Agreement ("Default") the other party, may, at its option,

- suspend or terminate its performance until such Default has been corrected, provided/ however, that no termination shall be effective until the complaining party has given written notice of a Default to the other party and the other party has failed to cure such Default within at least ten (10) days.
- 9. INDEMNITY. Customer agrees to indemnify, defend and hold harmless the City of Griffin against all claims, damages, suits, penalties, fines and liabilities (including attorneys' fees) arising out of any actual or alleged (a) breach by Customer of the terms and conditions of this Agreement, (b) deposit of any Excluded Waste in the City of Griffin's equipment, or (c) injury to or death of a person or loss of or damage to property that may arise out of Customer's use, operation or possession of any such equipment.
- 10. EXCUSED PERFORMANCE. Neither party hereto shall be liable for its failure to perform or delay in performance hereunder due to contingencies beyond its reasonable control, including, but not limited to, strikes, riots, compliance with laws or governmental orders, fires and acts of God, and such failure shall not constitute a Default under this Agreement.
- 11. **BINDING EFFECT.** This is an Agreement on the part of both the City of Griffin, and Customer and their respective heirs, successors and assigns, in accordance with the terms and conditions set out herein. This Agreement shall not be affected by any changes in the Customer's Service Address if such new address is located within the City of Griffin's service area.
- 12. **ENTIRE AGREEMENT.** This Agreement represents the entire understanding and agreement between the parties hereto and supersedes any and all prior agreements, whether written or oral, that may exist between the parties.
- 13. RIGHT OF FIRST REFUSAL. Customer grants to the City of Griffin a right of first refusal to match any offer which Customer receives (or intends to make) after the completion of the initial Term or any Renewal Terms of this Agreement relating to any services provided hereunder, and further agrees to give the City of Griffin prompt written notice of any such offer and a reasonable opportunity to respond to it.
